4. KYLE ZIMBELMAN: Update on Permit Software Trakit

The Trakit Kick-off took place last week, introducing the Permit Software to County Staff/employees. The new software program allows online access to schedule inspections, submit permits, and make payments by credit card. Kyle Zimbelman will send out a calendar, highlighting upcoming Trakit milestones for the next year. Trakit is scheduled to go "live" May 2018.

Discussion ensued.

Kyle Zimbelman explained the benefits of services such as fee estimator, contractor information, and property and permit information available online through new software program. Trakit will allow the customer to schedule inspections, and cancel inspections. Kyle Zimbelman will offer more information after processes are discussed at the next phase of Trakit meetings.

5. KYLE KRAUSE, Deputy Building Official – Report on CBSC Committee Meeting regarding Exterior Elevated Elements (EEE)

Kyle Krause attended the CBSC (California Building Standard Commission) State of California, Building Standards Commission Hearing on the Exterior Elevated Element subcommittee where the discussion to improve exterior balconies and other issues exposed to weather took place. Kyle Krause explained how the adoption cycle works and the processes are adopted by the commission and filed by the Secretary of State.

Kyle Krause demonstrated how to access the Building Standards Commission website: www.bsc.ca.gov. Kyle Krause showed how to locate and access information. Tom Burnette highly recommended the website as a useful resource.

6. CHAIRMAN DISCUSSION: JERRY HOMME

Tom Burnette spoke about the Amendment to Title 14, Fire Safe Regulations. Tom Burnette is trying to get final agreements on amendments and suggested a subcommittee within BIAC be formed. Jerry Homme proposed that BIAC put together a subcommittee, Jeff Haberman, Jerry Homme, Earl McGuire and Gary Gates volunteered to make up this subcommittee.

Tom Burnette will send information on amendment to the subcommittee to peruse. The subcommittee will set a time to meet.
