BYLAWS

1. AUTHORITY AND DEFINITIONS

The following Bylaws of the Building Industry Advisory Committee of the County of El Dorado, hereinafter referred to as the **BIAC**, are hereby adopted pursuant to Section 65102 of the Government Code of the State of California and Section 2.20.650 of the El Dorado County Code.

2. OFFICE

The principal office of the **BIAC** shall be at the El Dorado County Government Center, 2850 Fairlane Court, Placerville, CA.

NOW, THEREFORE, BE IT RESOLVED RESOLUTION NO. 164-2010 that the Board of Supervisors of the County of El Dorado, California, establishes the membership and sets forth the responsibilities of the BIAC as follows:

Section 1. <u>COMMITTEE STRUCTURE</u>. The Committee shall consist of five members appointed by the Board of Supervisors with a three-year term. The Board of Supervisors shall appoint one member and one alternate from each of the following organizations and two "at large" members. In addition, the Development Services Department, Building and Planning Divisions and the El Dorado County Fire Chiefs Association shall serve as technical advisors to the Committee.

- a. Active contractors in good standing.
- b. North State Building Industry Association of Sacramento Building Exchange.
- c. Surveyors, architects, geologists and engineers (SAGE) of El Dorado County

Section 2. <u>MEETINGS</u>. The Building Industry Advisory Committee <u>will meet quarterly</u>. Additional meetings may be added if deemed necessary by the committee members and/or Development Services staff. The meetings will be noticed in accordance with the Brown Act. A quorum of three voting members is necessary to conduct official Committee business.

a. Special meetings of the Committee may be called by the Chair or any three members of the Committee by notifying the Executive Secretary, stating the purpose, time, and place of the meeting at least 96 hours before the time set forth. The Executive Secretary shall thereupon notify each member of the purpose, time, and place of the

meeting at least 72 hours before the time of the meeting. An agenda of said meeting shall be posted at least 72 hours prior to the meeting and notice of a special meeting shall also be given to the news media.

b. Meetings may be adjourned to another time and place by the Chair with majority concurrence. The Chair shall give public notice of the time and place during the meeting so adjourned.

Section 3. <u>**RESPONSIBILITIES**</u>. The Building Industry Advisory Committee shall make recommendations to the Board of Supervisors and the Development Services Department on policies and procedures related to the building industry.

Section 4. <u>OFFICERS</u>.

- a. The officers of the BIAC shall consist of a Chair, First Vice Chair, Second Vice Chair, and an Executive Secretary.
- b. The Chair and Vice Chair will have a 2-year rotating term from and by the voting members of the committee meeting in December and shall take office at the next regular meeting. Vacancies shall be filled in the same manner at the first meeting immediately following the time the vacancy occurs.
- c. The Chair shall act as the presiding officer at all the meetings of the committee
- d. The planning and Building Department Director shall be ex-officio Executive Secretary of the Committee. The Executive Secretary shall be responsible for the preparation of an agenda and for the keeping of minutes and shall deliver correspondence, reports and other matters on behalf of the Committee.

Section 5. <u>PROCEDURES</u>.

- a. Meetings shall be conducted in such manner as the Chair directs within the rules herein set forth and any regularly adopted agenda.
- b. A majority of the Committee shall constitute a quorum for the transaction of business. Majority shall mean three or more members of the total membership of five members. The only action which can be taken at a meeting attended by less than a quorum is to adjourn the meeting to a certain day and time to be determined.
- c. To be passed, all motions and resolutions must receive the affirmative votes of no less than the majority of the Committee unless otherwise required by law.
- d. Members of the Committee who are unable to attend a meeting shall, if possible, so inform the Chair, Executive Secretary or Clerk in advance of said meeting in order to determine a quorum in advance.
- e. Voting shall be by roll call. <u>Except on hearing items</u>, the Chair may elect to call for "all in favor" or "any opposed" verbal vote. All officers of the Committee, excepting the Executive Secretary, shall be able to vote.

- f. Any person desiring to appear before the Committee, except at public hearings, may have the matter placed on the Committee's agenda, stating the name of the party and the purpose of the appearance. The matter will be considered during Public Forum, pursuant to procedures adopted by the Board of Supervisors.
- g. Any question of procedure not governed by the rules herein set forth, shall be decided in accordance with the latest revised edition of Robert's Rules of Order.
- h. The Committee, by motion, may suspend or vary the application of these rules with regard to any proceedings or to any particular problem before the Committee.
- i. The agenda of all upcoming BIAC meetings will be discussed with the Chair prior to being published for the public.
- j. By majority vote of the BIAC the Chair may agendize the items through the Resolution of Intention process (used for hearing items).
- k. By majority vote of the BIAC, items discussed during Public Forum may be agenized for further discussion and/or action. These items will be placed on the next available agenda.
- 1. The BIAC may repeal, amend, or add to these rules by resolution.
