NOTICE OF AVAILABILITY of the DRAFT ENVIRONMENTAL ASSESSMENT/ENVIRONMENTAL IMPACT REPORT for the U.S. HIGHWAY 50/MISSOURI FLAT ROAD INTERCHANGE PROJECT,

and Supplemental EIR for the Missouri Flat Area Master Circulation and Funding Plan

(limited to the modification of one drainage-related mitigation measure)

Copies of a joint Draft Environmental Assessment/Environmental Impact Report for the U.S. Highway 50/Missouri Flat Road Interchange Project, and Supplemental EIR for the Missouri Flat Area Circulation and Funding Plan (limited to the modification of one drainage-related mitigation measure), a two-volume set, one volume being appendices, are now available for review and/or purchase. Public comment on this joint document is invited for a 45-day review period extending from December 22, 2003 through February 5, 2004. ***A public hearing on the joint DEA/EIR and Supplemental EIR, occurring during the public review period, will be held on January 15, 2004.***

With the Federal Highway Administration (FHWA) acting as federal lead agency and El Dorado County (County) acting as state lead agency, this joint document has been prepared to comply with the requirements of the California Environmental Quality Act (CEQA) of 1970, as amended (Public Resources Code, Section 21000, et seq.) and the National Environmental Policy Act (NEPA), as amended (42 U.S.C. 4321 et seq.).

The proposed "project" analyzed in the joint document under CEQA is more expansive than the "action" analyzed under the federal act. The CEQA proposed "project" is a 2-phase project, whereas the NEPA proposed "action" equates only with the first phase of that project. For CEQA purposes, Phase 1 of the project is an interim 4-lane tight diamond interchange, and the preferred Phase 2 (or the Ultimate Phase) configuration is a single point diamond interchange (SPDI). The County Board of Supervisors will only act on Phase 1 of this project at this time. The NEPA proposed action, in contrast, is only a 4-lane tight diamond interchange; this configuration is the same as the Phase 1 project for CEQA.
