Mosquito Road Bridge Replacement Project Department of Transportation Construction Update #7 May 3, 2024

The Mosquito Road Bridge Replacement Project construction has been underway since July 2022. This is the seventh quarterly construction update for the community:

January 2024

- Continued progress drilling and installing Pier 2 CIDH piles (approx. 31 of 35 total installed by end of month).
- Continued progress drilling and installing Pier 2 soldier piles (approx. 14 of 18 total installed by end of month).
- Continued installation of lagging for Pier 2 soldier pile retaining wall.
- Continued structure backfill for Pier 2 soldier pile retaining wall.
- Completed drilling and installing Pier 3 CIDH piles.
- Completed drilling and installing Pier 3 soldier piles.
- Continued installation of lagging for Pier 3 soldier pile retaining wall.
- Continued structure backfill for Pier 3 soldier pile retaining wall.
- Began Pier 3 footing subgrade and Vertical Shoring Tower (VST) footing excavation.
- Completed Drainage System #5 outfall wall.
- Continued site inspections & storm water sampling for erosion control compliance.
- Continued maintenance of storm water erosion control measures site wide.
- Continued site wide roadway sweeping as needed.
- Monitored Pier 2 & 3 inclinometers (no slope movement).
- Continued deliveries of Project concrete, rebar, and other materials.
- Continued Project batch plant concrete supply to north CIDH pile and soldier pile operations.
- Continue intermittent flagging and traffic control for equipment and materials deliveries.



May - July 2024 Anticipated Work

- 386 of 700 (55.1%) Project working days complete through the update date.
- Complete installation of Pier 2 soldier pile retaining wall lagging and structure backfill.
- Complete drainage ditches adjacent to Pier 2 ground anchor / soil nail retaining walls.
- Complete installation of Drainage System #7 outlet below Pier 2 soldier pile retaining wall.
- Complete installations of Pier 2 column reinforcing bars, interior / exterior forms, and concrete placements for column lifts 1-6 (out of 8 lifts total).
- Continue installations of Pier 2 column reinforcing bars, interior / exterior forms for lift 7.
- Complete structure backfill of soldier pile retaining walls at Pier 3.
- Complete drainage ditches adjacent to Pier 3 ground anchor / soil nail retaining walls.
- Complete installations of Pier 3 column reinforcing bars, interior / exterior forms, and concrete placements for column lifts 1-5 (out of 8 lifts total).

- Continue installations of Pier 3 column reinforcing bars, interior / exterior forms for lift 6.
- Begin 10-Week full closure of Mosquito Road at the gates from May 27, 2024, through August 2, 2024.

Work scheduled during the Mosquito Road full closure:

- Begin Drainage System #4 manhole construction at north approach, install drainage inlet at concrete lined ditch, and installation of 18" HDPE pipe under Mosquito Road from manhole to drainage inlet at concrete lined ditch.
- Complete installation of Drainage System #5 down pipe anchors adjacent to Mosquito Road.
- Begin Drainage System #6 installation adjacent to Mosquito Road at Pier 3.
- o Complete Drainage System #8 adjacent to Mosquito Road and BLM driveway.
- Complete installation of Project time-lapse cameras adjacent to Mosquito Road.
- o Continue materials and concrete delivery to Pier 3 column construction.
- Complete roadway and pothole repairs by DOT Maintenance Road Crew on Mosquito Road between Union Ridge and Mosquito Cutoff Road.
- Complete annual maintenance work by DOT Maintenance Bridge Crew on Mosquito Bridge.
- Continue to monitor Pier 2 & 3 inclinometers.
- Continue supplying north Project with batch plant concrete for Pier 3 construction.
- Continue intermittent flagging and traffic control for equipment and materials deliveries.
- Continue receiving Project equipment and materials.
- Continue inspection and maintenance of storm water erosion control measures as needed.
- Continue water quality sampling and testing of Project runoff as needed.
