
Trail Conditions / Observations: Staff entered the Rubicon Trail using the trail head at Loon Lake. Snow depths have diminished greatly as result of the temps holding near the 50's on average increasing the melt. The snow is mostly gone from the BMP's in the Ellis tie area with all features working as designed. The Walker hill site is surrounded with snow still and the inspection area showing very little water on the trail / working as designed. The drain @ Soup Bowl remains clear and effective resulting in low water depths again. Winter camp is draining as designed to the north keeping the water off of the hardened trail surface as designed. Little Sluice is still mostly covered in snow. Due to time restrictions from trail clearing (downed trees) staff focused on areas east of, and including, Ellis Creek Tie.

County Assessment: Out of the 7 inspection sites, 5 were inspected. All sites that were visited are working very well as designed.


