

## RESOLUTION NO. 061-2007 OF THE BOARD OF SUPERVISORS OF THE COUNTY OF EL DORADO

WHEREAS, the County of El Dorado is mandated by the State of California to maintain an adequate and proper General Plan; and

WHEREAS, because of that mandate El Dorado County's General Plan and the various elements thereof must be continually updated with current data, recommendations, and policies; and

WHEREAS, the Development Services/Planning Services Department and the Planning Commission have made recommendations to the Board of Supervisors regarding potential amendments of the Housing Element and the Land Use Element of the General Plan; and

WHEREAS, the Board of Supervisors has reviewed and held public hearings on the recommended amendments to the Housing Element and the Land Use Element; and

WHEREAS, the Board of Supervisors finds that the proposed amendments to the General Plan are consistent with all elements of the General Plan not otherwise amended.

NOW, THEREFORE, BE IT RESOLVED that the El Dorado County Board of Supervisors hereby approves and accepts the environmental document filed on the following amendments to the General Plan and approves and adopts the following amendments to the General Plan based on the findings and reasons set forth in the staff report and Planning Commission's action, except as may be noted herein:

Page 2 Resolution No.

- 1. HOUSING ELEMENT Policy HO-3g: Apartment complexes, duplexes, and other multifamily rental housing shall not be converted to condominiums for at least ten years after issuance of the Certificate of Occupancy. Apartment complexes, duplexes, and other multifamily rental housing that contain any units restricted to households earning 120 percent or less of the area median family income (MFI) shall not be converted to condominiums for at least twenty years after issuance of the Certificate of Occupancy.
  - 2. DIAMOND SPRINGS/EL DORADO AREA Medium Density Residential (MDR) to Multifamily Residential (MFR), consisting of 6.97 acres identified by Assessor's Parcel Number 327-160-47, being described as Section 23, Township 10 North, Range 10 East, M.D.M.
