  - Parcel Map P14-0001/Oak Trails Parcel Map submitted by THE OLYMPUS a. GROUP, INC. to request the following: 1) Tentative Parcel Map to create a gated subdivision of four single family residential lots measuring 10.01, 10.27, 10.55, and 11.37 acres; and 2) Design Waivers of El Dorado County Design and Improvement Standards Manual (DISM) for the following: a) Maximum dead-end street length of 2,640 feet per Volume III, Section 3.12 to be modified to measure approximately 3,600 feet in length; b) Roadway width minimum of 18 feet per Standard Plan 101C to be reduced to twelve feet for the portion of the roadway traversing Lot 4 after the turn-around; and c) Minimum right-of-way requirement of 50 feet per Standard Plan 101C to be reduced to 30 feet for the portion of the roadway traversing Lot 4 after the turn-around.. The property, identified by Assessor's Parcel Number 102-200-56, consisting of 42.26 acres, is located on the east side of Deer Valley Road, approximately 2 miles north of the intersection with Green Valley Road, in the Rescue area, Supervisorial District 4.
