NOTICE OF PUBLIC HEARING – GOLD NUGGET SELF STORAGE EXPANSION

As the County of El Dorado Zoning Administrator considers the Conditional Use Permit CUP18-0011/Gold Nugget Self Storage Expansion, submitted by Gary Kniesel, proposing the expansion of the existing recreation vehicle storage facility property, Assessor's Parcel Numbers 109-030-005 and 109-030-006, it is my concern that the El Dorado County Water Agency, Stormwater Resource Plan for watershed resource planning and stormwater runoff management for this area be considered and approved prior to the approval of any Conditional Use Permit being issued.

To adequately address the stormwater resource planning at this location and site it is important that the Stormwater Management and the Storm Water Runoff factors of this area be addressed and evaluated. Stormwater refers to "...surface water runoff and drainage generated by immediately preceding storms." Stormwater management is changing in California due to the increased awareness of stormwater related environmental challenges. These changes promote stormwater resource planning efforts that include both wet and dry weather flow management.

Because the Gold Nugget Self Storage Expansion is currently bisected by a local waterway, and the expansion is taking place in an area of local streams and waterways, and where seasonal high stormwater runoffs may inundate the immediate areas, the impact and remediation of such streams, waterways and stormwater runoff being impacted by the expansion, needs to be evaluated and resolved prior to the issuance of any Conditional Use Permit being issued to the Gold Nugget Self Storage Expansion.
