Dear County of El Dorado Zoning Administrator,

As a resident of Cameron Park and the Cameron Park Airport District I would like to strongly express my objection to developing a Self-Storage facility by the Cameron Park Airport. As one of the very few airports in the county, the Cameron Park Airport serves a large part of the county's population around Cameron Park, El Dorado Hills, and into neighboring Sacramento county. The airport supports recreational flying, commuting, extensive flight training, and is a destination airport for the foothills and Gold Country. The airport also serves local law enforcement through the Sheriff's Air Squadron as well as emergency services. The airport unfortunately is land locked and in desperate need of land to develop hangars, tie-downs, and aviation related businesses. Self-storage facilities can be developed in many other locations, and it seems Cameron Park already has its fair share of self-storage facilities. The only option for improving and developing the airport with aviation related businesses is the undeveloped land adjacent to the airport.

The official tagline for Cameron Park Community Services District is "A special place to live" and that is not due to storage facilities, but the history of Cameron Park, the location in the foothills and Gold Country, great neighborhoods and good school districts, the very unique residential Cameron Park Airpark, the Cameron Park Country Club, and the parks.

I am asking that we ensure improvement and development of the airport, that is part of making Cameron Park "A Special place to live", by reserving the land planned for a self-storage facility to aviation related businesses.

This request for a Self-Storage Facility must be DENIED as it is located on the Cameron Park Airport. The plan for a Self-Storage Facility is totally unacceptable as it destroys the land for future Aviation Related and Public Safety needs. The following reasons for the Denial are as follows:

 and is part of the wide ranging issues and benefits included in the national airport system, the

- Further, the slope and topography of the site relative to the access of sewer may necessitate a sewer lift station which is not considered in the current design.

I write you all to encourage you to Vote NO to this request and any future request for the utilization of this property for non aviation related use. The siting for a Self-Storage Facility at the Cameron Park Airport is the major issue facing the approvals necessary. Aviation Safety as discussed in the CLUP is not much considered. And the future need for this land to be reserved for Aviation Related Use is not even discussed. Vote NO to this proposal.

Dear County of El Dorado Zoning Administrator,

I am a resident of Cameron Park and live in the Airpark and I would like to express my strong objections to the proposed development of a Self-Storage facility adjacent to the Cameron Park Airport.

I moved here two and a half years ago after long search for place to live with my airplane near a large city. Cameron Park was perfect; great community inside and outside the airpark, close to stores, restaurants and the Serra mountains. It is special place to live!

Cameron Park Airport is used by Cameron Park residences and surrounding communities for recreational, business and commuting flights. The aircraft tie-downs and hangars are all leased with waiting lists. The airport is also a destination for pilots, family, friends and business associates. The airport's location near the Sierras, rafting, and wineries, makes it attractive for visitors from Southern California, the Bay Area and in between. Those flights bring revenue to local businesses and taxes to the county. Cameron Park Airport serves law enforcement, medical emergency flights and emergency services. The airport also hosts the only flight schools in the area, training tomorrow's recreational and commercial pilots.

I object to the proposed Air Park Self Storage for four reasons: 1st, The land should be used for aviation related business for the reasons above as there is no space at the airport and there is demand for additional aircraft tie-downs, hangars and transit parking. Self-Storage can be developed in many areas where as aviation businesses with airplanes can only be developed next to the Airport. 2nd, the current plans still have access from the Self Storage to the airport taxiway. This cannot be allowed! Even it is intended to be for emergency, it is very unlikely it would stay that way and the airport cannot be obligated to maintain access. Mixing cars, truck and people not familiar with airport safety is not good for the people and aircraft that operate at the airport in addition to security issues. 3rd, having a selfstorage facility, with storage building, walls, etc, detracts from the character of the airport and local community. Granted it may look better than the current use, but is it permanent. 4th Does Cameron Park really need another self storage, especially along a main road? I don't think so.

Cameron Park is "A special place to live". Cameron Park Airport is one of many elements that make it special. I don't believe another self-storage at the airport, especially next to it, adds to making it special in a positive way.
