The County of El Dorado Zoning Administrator will hold a public hearing in the Building C Hearing Room, 2850 Fairlane Court, Placerville, CA 95867 on October 7, 2020, at 3:00 p.m., to consider the following: Tentative Parcel Map P19-0008/Crowley submitted by JON D. CROWLEY JR. AND TERESA G. CROWLEY to subdivide a 15.92 agre parcel into two parcels of 9.06 acres (Parcel 1) and 6.86 acres (Parcel 2). The property, identified by Assessor's Parcel Number 109-330-034, consisting of 15.92 acres, is located on the south side of Milton Ranch Road, approximately 160 feet west of the intersection with Barnett Loop Road, in the Shingle Springs area, Supervisorial District 4. "This is a notice of intent to adopt the negative declaration or mitigated negative declaration that has been prepared for this project and which may be reviewed and/ or obtained in the County of El Dorado Planning and Building Department, 2850 Fairlane Court, Placeville, CA 35667, during normal business hours or online at https://edc-trk.aspgov.com/etrakit/Search/project.aspx by typing the first word of the project name in the search box. A negative declaration or mitigated negative declaration is a document filed to satisfy CEQA (Callifornia Environmental Quality Act). This document states that there are no significant environmental effects resulting from the project, or that conditions have been proposed which would mitigate or reduce potential negative effects to an insignificant level. The public review period for the negative declaration or mitigated negative declaration set forth in CEQA for this project is thirty days, beginning September 5, 2020, and ending October 4, 2020 (or next business day).
