The County of El Dorado Zoning Administrator will hold a public hearing in the Building C Hearing Room, 2850 Fairlane Court, Placerville, CA 95667 on October 21, 2020, at 3:00 p.m., to consider the following: Tentative Parcel Map P19-0016/Granade/Barsotti submitted by DOUGLAS GRANADE to divide a vacant 14.62-acre parcel into two 7.31-acre parcels. The property, identified by Assessor's Parcel Number 109-240-030, consisting of 14.62 acres, is located on the northwest side of Shingle Lime Mine Road, approximately 500 feet south of the intersection with Durock Road, in the Shingle Springs area, Supervisorial District 2. (County Planner: Tom Purciel, 530-621-5903) (Categorical Exemption pursuant to Section 15315 of the CEQA Guidelines)

All persons interested are invited to write their comments to the Zoning Administrator in advance of the hearing. If you challenge the application in court, you may be limited to raising only those items you or someone else raised at the public hearing described in this notice, or in written correspondence delivered to the Zoning Administrator at, or prior to, the public hearing.
