The County of El Dorado Zoning Administrator will hold a public hearing in the Building C Hearing Room, 2850 Fairlane Court, Placerville, CA 95667 on November 17, 2021, at 3:00 p.m., to consider the following: Conditional Use Permit CUP20-0013/Slate Creek Animal Hospital submitted by PAUL AND CHRISTINA VOS to allow a Conditional Use Permit bringing an existing 1,936 square foot legal non-conforming veterinary clinic into compliance with zoning standards and to allow for the 1,886 square foot large animal care expansion with associated increased parking facilities. The property, identified by Assessor's Parcel Number 331-040-026, consisting of 2.17 acres, is located on the south side of Mother Lode Drive, approximately 300 feet west of the intersection with Davidson Road, in the El Dorado area, Supervisorial District 3. (County Planner: Evan Mattes, 530-621-5994) (Categorical Exemption pursuant to Section 15301 of the CEQA Guidelines)
