The County of El Dorado Zoning Administrator will hold a public hearing in the Building C Hearing Room, 2850 Fairlane Court, Placerville, CA 95667 on August 4, 2021, at 3:00 p.m., to consider the following: Minor Use Permit MUP21-0001/Liberty Utilities Security Fencing submitted by KELLEY KELSO, ASCENT ENVIRONMENTAL to allow the replacement of a security fence around the Liberty Utilities Meyers Substation perimeter, consisting of: 11 foot 6 inch high chain-link fence with a foot of barbed wire above. The barbed wire will be at a 45 degree angle to the fence facing the exterior of the substation yard. Total height of the finished fence will be 12 feet 6 inches. The property, identified by Assessor's Parcel Number 081-031-002, consisting of 9.59 acres, is located at 2548 Garbage Dump Road, on the north side of Garbage Dump Road, approximately 0.6 mile northeast of the intersection with Pioneer Trail, in the South Lake Tahoe area, Supervisorial District 5.
