The County of El Dorado Zoning Administrator will hold a public hearing in the Building C Hearing Room, 2850 Fairlane Court, Placerville, CA 95667 on November 17, 2021, at 3:00 p.m., to consider the following: Variance V21-0001/ Danaher submitted by MIKE DILL, ASPEN ENVIRONMENTAL to allow a reduction of the front setback from 20 feet to 0 feet to allow for the construction of a two-car garage. The property, identified by Assessor's Parcel Number 021-401-004, consisting of 0.6 acre, is located on the south side of Fallen Leaf Rd, approximately 2 miles south of the intersection with Tahoe Mountain Road, in the South Lake Tahoe area, Supervisorial District 5.
