The County of El Dorado Zoning Administrator will hold a public hearing in the Building C Hearing Room, 2850 Fairlane Court, Placerville, CA 95667 on August 17, 2022, at 3:00 p.m., to consider the following: Tentative Parcel Map P21-0004/Jomescbo submitted by THOMAS R. VAN NOORD/ JOMESCBO FAMILY TRUST to divide an approximately 55-acre property into four (4) parcels ranging between ten-acres to approximately 20.25 acres of total parcel area. The property, identified by Assessor's Parcel Number 105-190-042, consisting of 55 acres, is located on the south side of Thompson Hill Road, approximately 200-feet east of the intersection with Lotus Road, in the Gold Hill area, Supervisorial District 4.
