The County of El Dorado Zoning Administrator will hold a public hearing in the Building C Hearing Room, 2850 Fairlane Court, Placerville, CA 95667 on January 19, 2022, at 3:00 p.m., to consider the following: Tentative Parcel Map P21-0005/El Dorado Senior Village Apartments submitted by SERGEI OLESHKO for a streamlined ministerial Tentative Parcel Map Permit in accordance with the provisions of California Senate Bill 35 (SB 35) (Streamlined Ministerial Approval of Affordable Housing) for a Tentative Parcel Map reconfiguring two (2) lots existing as a 5.881-acre parcel and a 2.31-acre parcel into two proposed lots of 3.56-acres (Parcel One) and 4.51-acres (Parcel Two). The property, identified by Assessor's Parcel Number 331-221-034, consisting of 8.2 acres, is located on the south side of Pleasant Valley Road, approximately 600-feet west of the intersection with Koki Lane, in the El Dorado area, Supervisorial District 3. (County Planner: Matthew Aselage, 530-621-5977) (Statutory Exemption pursuant to Section 15268 of the CEQA Guidelines)

If you challenge the application in court, you may be limited to raising only those items you or someone else raised at the public hearing described in this notice, or in written correspondence delivered to the Zoning Administrator at, or prior to, the public hearing.
