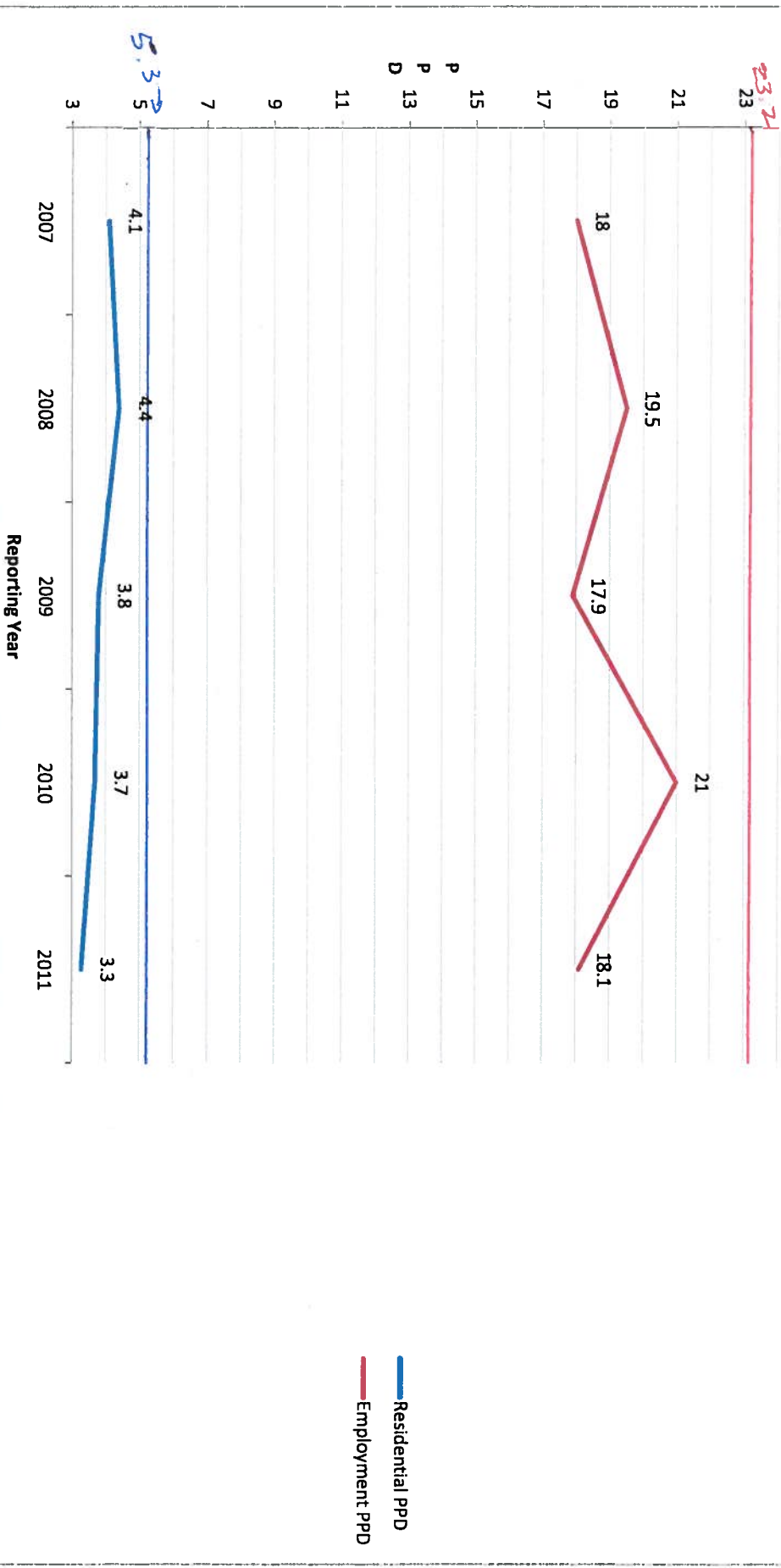

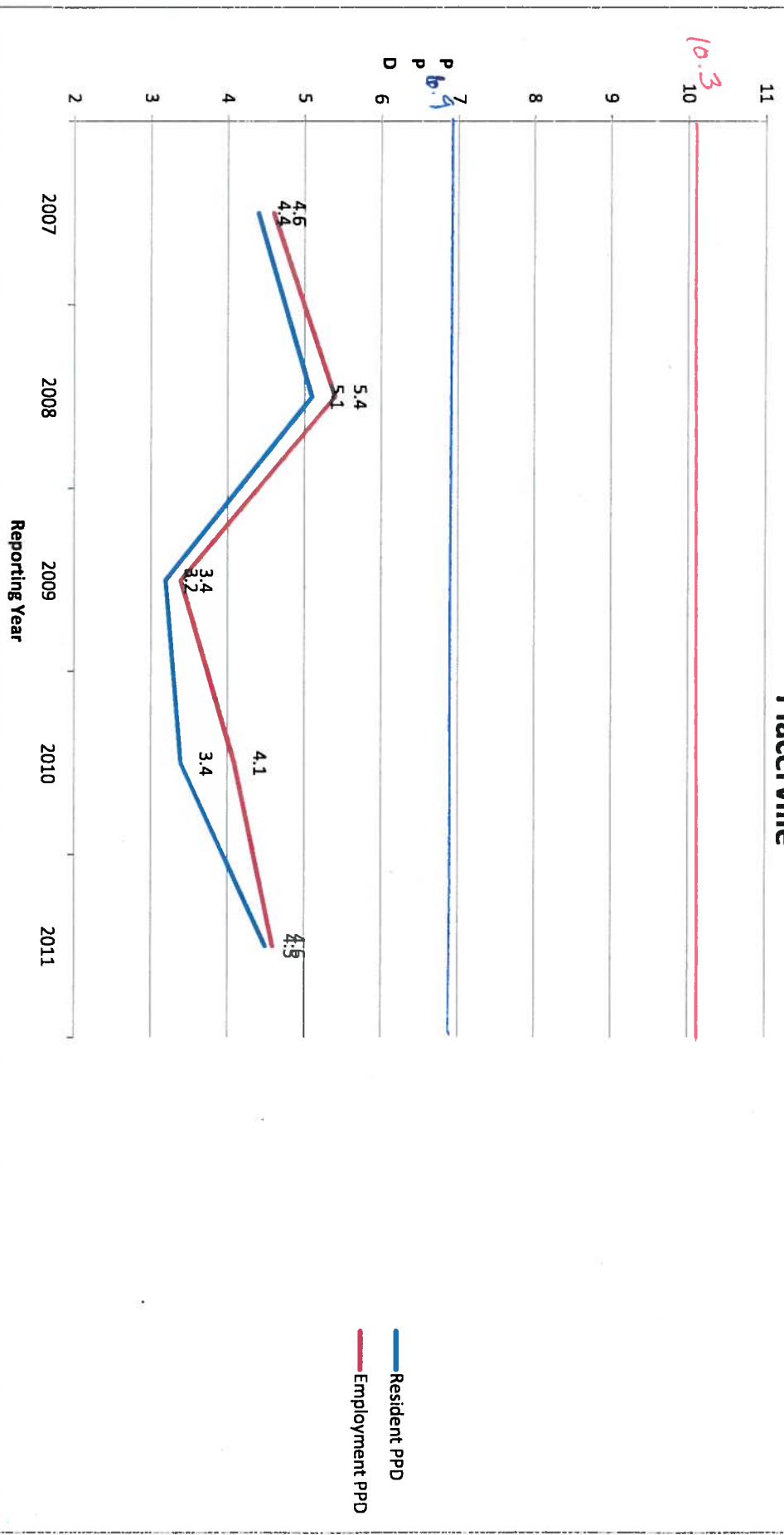

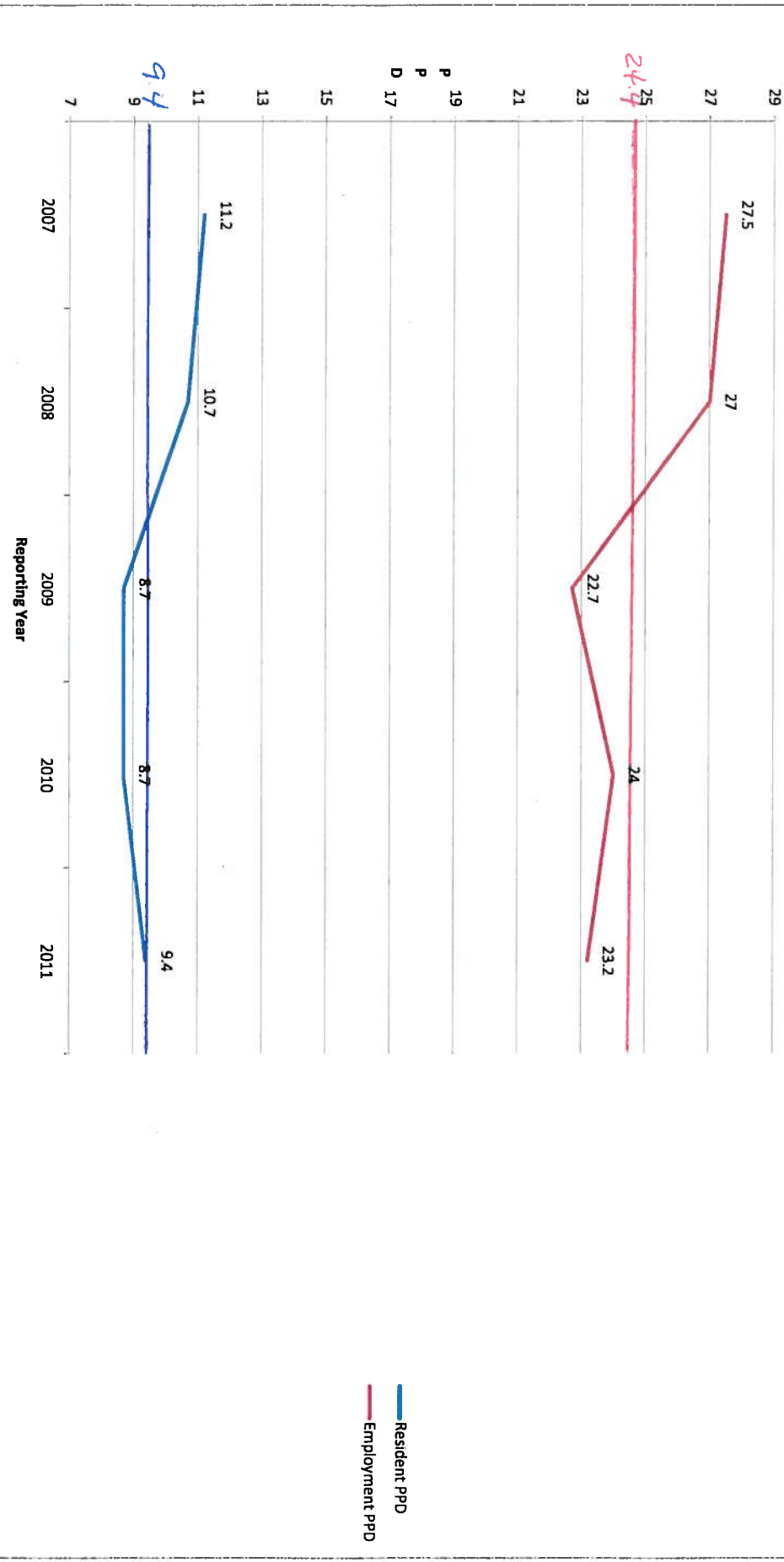

distances (as pointed out in the comment). Related to potential collection vehicle impacts, the Plan includes strategies to achieve truck emissions reductions, including Strategy 2.18 (Reduce Emissions from Collection Fleets, page 5-7) and Strategy 2.19 (Use Advanced Technologies for Collection Trucks and Vehicles, page 6-8). Depending on the site location selected for Strategy 3.9 (Develop a West Slope C&D Processing Facility, page 4-33), during periods of new development expected to be concentrated on the western-most side of the County, this strategy could help reduce overall debris box and commercial collection truck travel times, leading to overall emissions reductions.

The Plan includes a number of other strategies which will help the County achieve AB 32 emissions reduction targets, including greater use of containerized collection to reduce total vehicle miles traveled (Strategy 1.4, Expand Mandatory Residential Collection Ordinance (page 4-16), Strategy 2.6, Expand Use of Curbside Recycling Programs (page 4-26); implementation of a mandatory commercial recycling program (Strategy 2.4, page 4-24); enhancement of composting programs (Strategy 2.13, page 4-30); and numerous strategies that divert waste from the landfill. The County will consider the combined impact of all of these Plan strategies in assessing its ability to meet AB 32 requirements.

## **2.2 Subject Area: County Implementation Efforts**

### **Response**

The County has identified, and prioritized, a range of solid waste management strategies, in the Action Plan portion of the Plan that the County expects could be reasonably implemented through actions of the County jurisdictions, residents, and solid waste franchisees. The Action Plan identifies the details and implementation timing for each of these strategies. Subject to such factors as funding availability and jurisdictional approvals, the County expects to proceed with implementing the strategies as they are presented in the Action Plan.

## **2.3 Subject Area: Plan Accountability**

### **Comment #2 (part 2)**

Will there be diligent accountability?

### **Response**

The jurisdictions contributing to the Plan have prioritized performance tracking as a way to measure Plan outcomes. Measurement efforts are described in goal 10 of the Executive Summary (page 12) and objective 5 of the Executive Summary (page 13). Performance measurement is further detailed in Strategy 5.1, Identify Appropriate Performance Metrics for Each Selected Strategy (see page 4-38 of Volume II) and Strategy 5.2, Determine and Implement Appropriate Performance Tracking (see page 5-11 of Volume II).

## **2.4 Subject Area: Commercial Recycling – Pesticide Containers**

### **Comment #4**

My one comment on the Draft Solid Waste Management Plan would fall under the implementation of the Commercial Recycling Program. Currently the nearest facility for farmers to recycle pesticide containers is a transfer facility in North Highlands. Many of

This included total number of permits subject to the C&D Ordinance, the total reports received and the total amount of tonnage diverted. (See attachment) The handout lacks a key performance measurement: Percent diversion from landfill of C&D waste for building projects subject to the County C&D Ordinance requirements. EMD is revising the current C&D Ordinance to incorporate the new Green Building Code requirements and to improve waste diversion through implementation of the recommendations documented in the El Dorado County Solid Waste Management Plan (Strategy 2.5, "Enhance and Enforce the Construction and Demolition (C&D) Debris Ordinance.") EMD staff was requested to provide the revised DRAFT C&D Ordinance to the EDSWAC committee. EMD was also requested to provide at the next EDSWAC meeting a schedule for completing the revised C&D Ordinance for presentation to the County Board of Supervisors.

**b) Fire Safe Council Chipping Program – Richard Krek**

Richard Krek was absent from the meeting. Mary Cahill stated she would discuss with Richard the information and bring the information to the next meeting.

**c) El Dorado Disposal to report on the Green Voucher Program – Jeff England**

Sue VanDelinder reported for El Dorado Disposal that this program is up and running. This has been a very popular program in the past but so far only 51 vouchers have been received.

Jeanne Lear is working on the 2010 4<sup>th</sup> quarter report. STR has mixed recycling pick-up at all schools in SLT and in the Nevada service area. CalRecycle grant funded school presentations are starting. The next step is to get bear resistant containers for ball fields.

Jeanne and Christian are working on another grant to obtain dumpster enclosures for about a dozen apartment complexes. Christmas trees are being collected. Earth Day will be celebrated on April 16<sup>th</sup>. The clean up day is always the first Saturday in June.

**H. Sierra Disposal –**

During the Cool clean-up in October, four 40-yard containers of waste were collected. During the Garden Valley clean-up in October, three 40-yard containers of waste were collected. 





AB 323 Chesbro D)

Introduced: 2/12/2013

pdf html Solid waste: recycling: diversion: green materials.

4/30/2013 - From committee: Do pass and re-refer to Com. on APPR. (Ayes 6. Noes 3.) (April 29). Re-referred to Com. on APPR. This bill would require CalRecycle to adopt regulations to reduce organics and greenwaste directed to landfills. Specifically, the bill (1) requires CalRecycle to adopt regulations to phase-out diversion credit for greenwaste used as alternate daily cover (ADC) by 2020, with the ability to implement regional phase-out timelines and delay the effective date of the regulations for two years, (2) requires CalRecycle to investigate specified materials for ADC use, and adopt regulations meeting minimum standards for those materials for ADC if CalRecycle determines them adequate, (3) defines "large-quantity commercial organics generator" as a business that generates significant amounts of organic waste, including food and green waste, as determined by CalRecycle, (4) requires CalRecycle to adopt regulations to require large-quantity commercial generators of organic waste to source separate and subscribe to recycling for this material, with the ability to establish different implementation timelines for various materials and regions, implemented no later than 2017.

Michael Tilley reported that Environmental Management explored interest in creating a West Slope JPA and there didn't seem to be sufficient interest. The representatives from the two CSD's (Mary Cahill - Cameron Park CSD, and Sandi Kukkola – El Dorado Hills CSD) stated there was no "formal" presentation or decision made regarding interest on their part in creating a West Slope JPA. George Turnboo stated that there have been 28 other jurisdictions that have adopted our plan, and he would like to know what they have done to change or implement the goals in it (specifically if they created a JPA and how they did it).

The Committee discussed possibly creating a section on the websites of either Environmental Management or EDSWAC that shows what the Objectives and Strategies in the Solid Waste Management Plan are and a timeline of how and when the Objectives or Strategies will be met. If an Objective or Strategy has been accomplished then information on how and when it was accomplished should be clearly stated.

A list of upcoming Grant opportunities that might assist EDSWAC or the County in accomplishing specific strategies in the Management Plan will be provided at the next EDSWAC meeting by County Staff.

**a) County of El Dorado – Michael Tilley**

**i) Staff Reports**

New Solid Waste/Hazardous Materials Technician, Amber Forest, started with the County today. Another new Solid Waste/Hazardous Materials Division employee will start in two weeks.

**ii) Meeting AB 939 Goals**

Mike reported that he just finalized the EAR for the unincorporated area of El Dorado County and Placerville. The unapproved diversion percentage for the unincorporated area is at 65.6% diversion for 2012. Official Placerville numbers were not available but it was reported they may be up in the 60% range. South Tahoe Refuse reported they are at 54%. South Tahoe Refuse has requested CalRecycle give a breakdown of how the numbers are developed because they don't feel neither the population nor the employment calculation adequately reflects the situation in their resort oriented economy.

The collection of items by Snowline Hospice is being reflected in the diversion reports of the City of Placerville. Debi Harlow reported the items not being tracked are restaurant oil, big box cardboard numbers and tires. Debi has offered her assistance in figuring out a way to collect diversion numbers for items not being captured. Mike Tilley responded that the new reporting is focused on disposal and the diversion of materials kept out of the landfill. Daisy with CalRecycle stated that under AB939 Requirements, programs are also considered.

**iii) Legislative/Regulatory Update**

SB341 is the bill increasing diversion to 75% by the year 2020. CalRecycle needs to have a plan in front of the Governor for how they will get from here to there; however, AB32 Greenhouse Gases & Emissions has been a challenge to this being accomplished because the CalRecycle staff needs to

**4) Old Business**

**a) C & D – Update from C&D Subcommittee – Michael Tilley**

The C&D Subcommittee has created a Draft C&D Ordinance (submitted to Committee Members). Dickson wanted comments and questions from Members; she began:

Dickson:

- Should the Ordinance say meeting a 75% diversion rate instead of 50% diversion rate since it will be a requirement in the near future? Something to ask Gerri before the final draft is created.
- On Page 5 - Create an easy Check List to include for applicants
- On Page 6 - Add frequency on performance measures

Don:

- One of the biggest changes is that the current Ordinance only covers permits that are over 5,000 square feet or Master Plan homes; this new Ordinance will cover ALL permits.

Debi: What is the process when applicants apply for a permit? Answered below in Item b.

There is still a lot of work to be done before new Ordinance changes can be implemented. There are forms to be created and possible fees that will be assessed if the Ordinance requirements are not met. New fees will require approval by the Board of Supervisors.

A motion was made by Don Nizolek that EDSWAC submits a letter to Gerri Silva indicating that EDSWAC has approved the work that was done on the new C&D Ordinance. EDSWAC emphasizes this Ordinance move forward and be presented at the first meeting in April or sooner to the Board of Supervisors. This letter will be included with the C&D Ordinance when it is presented to the Board of Supervisors. This motion was seconded by Dickson Schwarzbach.

**b) Representative from Building Services to discuss CalGreen Implementation / C&D Requirements – Lynda Jorgensen**

Lynda Jorgensen distributed the checklist that is given to applicants for brand new homes (not master plan designs or commercial permits over 5,000 sq. ft) regarding the CalGreen Building Code requirements they must comply with. One of those requirements is Section 4.408 Construction Waste Reduction, Disposal and Recycling. This form is a checklist for the field inspectors; however, once a permit has been finalized, these forms are not scanned into the saved documents.

Currently, if a commercial project is over 5,000 square feet or if it is a Master Plan (subdivision) home application, the applicants are referred to Environmental Management staff. With the new Ordinance; Building Services will still route permit applicants to Environmental Management. This process will not change but a Waste Management Plan will be required prior to issuing a building permit. Once the Waste Management Plan has been accepted, Environmental Management staff will sign off the issuance of permit. Another component of the new Ordinance is that Environmental Management will not sign of the Certificate of Occupancy until their Final Report on their Waste Management Plan has

been submitted. Once this goes into effect, it will require an upgrade to the permitting system to add another rule set that would route ALL permits to Environmental Management for C&D signoffs.

It was asked what the turnaround would be once an applicant has turned in their Waste Management Plan before their permit is approved for issuance. The guide that was used was the Health and Safety Code requirement for food facility plan checks which is twenty business days. Most plan checks are completed more quickly than the twenty business days; however, with the increased volume of permits it is not yet determined how long it will actually take.

There are numerous forms that are being developed with a majority of them very close to completion. It is being advised that quarterly reports be submitted to help the applicants keep on top of the reporting process. Then at the final, there will be only one last quarter to submit.

Lynda Jorgensen suggested that community education being done to let contractors know of the new requirements for C&D. It was suggested that information be posted on websites and a possible workshop be done. Reaching out to the El Dorado County Builder's Exchange was also suggested.

Don wanted to know when the Green Building Code came out in 2010, how the Building Services Division was verifying that Section 4.408 Construction Waste Reduction, Disposal and Recycling was being met, and what was being submitted as far as reports to ensure they met the 50% diversion of their waste. It was discussed that there was no follow-up on permits that were not meeting the current C&D Ordinance requirements. The County is still in compliance since our diversion rate is over the required 50% requirement.

**c) CSD's and Waste Hauler's – Strategies to achieve 5% additional Diversion**

Jeff England with El Dorado Disposal reported they used the Waste Management Plan to accomplish some of the big ticket items. Some of the items that were accomplished were:

- Composting – EDD developed a composting garden that is used as part of their overall outreach program. They have a partnership with the El Dorado County Master Gardeners and MORE for this project. They hope this is the beginning step to work towards food composting. EDD is looking to Sacramento County as a model, since they have a digester that they are implementing into their programs. There are discussions about possibly allowing EDD to bring waste down to Sacramento. Technologies are now coming into existence to allow these types of programs to get started. There is a lot of education needed with the public on how the program would need to work because there is a lot of contamination potential. They feel they were one to two years away from creating a food waste route in El Dorado County.
- During various times of the year, as an example at Rate Increase meetings, strategies in the Waste Management Plan are addressed.

George Turnboo brought up that new technologies should be looked at to help increase our diversion numbers.

Jeanne Lear with South Tahoe Refuse stated that they feel they finally have the facilities that they need to facilitate new recycling approaches. They are also looking at a five-year plan for facilities in Nevada. In the meantime, they are still running their existing food waste program and have added another elementary school. There is talk about expanding the program to all elementary schools. They are looking at the contamination aspects because it has to be done right. On the C&D side, their new space in their organics building provides the space needed to sort through the Construction and Demolition items that are brought in. They have also been screening all the material and sending the dirt to landfill for alternate daily cover. A switch from blue bags to carts is being explored. A customer

survey has gone out and they are waiting for the results. Recently, the City of South Lake Tahoe banned plastic bags so they feel the switch is most likely going to happen.

South Tahoe is still waiting to find out how the State will qualify or quantify the MRF's. Next year, South Tahoe is in a reset year, and that is when they usually discuss new programs.

EDHCSD, Sandi Kukkola brought in a handout (AB 939 Diversion Report) regarding what is currently being diverted from the landfill from within the El Dorado Hills Community Services District. EDH is reporting a 66% diversion rate and feels that education is one of the best ways to get people to recycle more.

Don Nizolek pointed out the diversion rates from 2009 and then from 2012, and he wanted to point out that the trends are not going up based on all the efforts that are going into it.

Jeanne Lear responded that South Lake Tahoe challenged the two ways to calculate the percentages, population and employment because it just doesn't actually reflect their resort community.

**d) Potential Grant Opportunities to achieve Solid Waste Management Plan Strategies.**

Mike Tilley passed out a handout (Grants and Award Programs) to the committee members.

- The County is taking advantage of OPP4, and the City/County Payment Program. The City/County Payment Program has been a great grant but it is going away. Work is being done on An Illegal Dump Site Grant and a Tire Amnesty Grant. When the County is working on grants; they can be brought to EDSWAC to see how they may apply to any of the strategies.
