RE: Caldor Recovery update

Please accept this memo as a weekly update to the activities surrounding the County of El Dorado's recovery from the Caldor Fire as managed by the Recovery Operations Center's (ROC) co-directors Sgt. Moke Auwae and me.

Environmental Management

- **Alternate Program**
 - 29 Applications received (reduced from 30 due to transitioning to State program for Tree Only)
 - 29 Work plans received
 - 26 Work plans approved
 - 17 parcels cleaned and sampled
 - 14 parcels have completed the program. 12 in Grizzly Flats & 2 in Twin Bridges
 - 15 "10-Day Notice to Abatement Letters" sent to parcel owners via email and certified mail.
 - 15 Parcels will be posted with the "10 Day Notice of Abatement" letters by 6-20-22
- **Public Program**
 - 590 debris removal complete (99%)
 - 576 Soil Samples approved (94%)
 - 24,215 Trees felled (85%)
 - 617 parcels with completed tree felling (92%)
 - 27,100 tree removal complete (95%)
 - 638 parcels with tree removal completed (94%)
 - 482 completed Full ROE final sign off (returned to owners)
 - 149 Tree-only final sign off
- **USFS Recreation Cabins**
 - EMD activated usfsroe@edcgov.us for submittal of USFS Cabin ROE's
 - 175 USFS ROE's in both paper and electronic format*
 - 62 USFSROE's approved and entered on the State smartsheet.

 - 2 Building Permits Issued/Approved w/out Permit Fees Waived
- Participated in the West Slope Foundation- Grizzly Flat Community distribution event at Pioneer Elementary June 12, 2022.
- Staff fielded various calls and emails regarding the USFS ROE for cabins along Highway 50.

Health and Human Services Agency

- Long Term Recovery and Immediate Needs Groups
 - No meeting this reporting week.
- Caldor Mental Health Worker
 - HR reported today that the Mental Health Worker is still finalizing background; start date has been pushed to July 2, 2022.
- Housing Disability Advocacy Program (HDAP)
 - EDC HDAP officially launched 6/15, and the HDAP team will be reviewing new referrals. HHSA will accept referrals sent to hdap@edcgov.us beginning 06/15/2022 and will continue to accept for 10 days. The initial referral window will close on 06/25/2022. Because we are anticipating a large number of referrals, program staff will reach out to all referrals to complete an intake packet and assess vulnerabilities. We will initially accept the top 6 most vulnerable referrals, with an emphasis on Caldor survivors.
- Staff attended the West Slope Foundation's monthly distribution event June 12, 2022.
