# **PURPOSE AND GOALS**

The purpose of the Plan Advisory Group (PAG) is to provide input and feedback to inform the 2024 Water Resources Development and Management Plan (WRDMP) update for El Dorado County.

The goals of the PAG are to:

- 1. Review and provide input on the proposed WRDMP Update.
- 2. Foster collaboration amongst agencies to address future water resource needs.

#### **BACKGROUND**

The WRDMP is a countywide water plan developed for implementing the charges provided by the 1959 El Dorado County Water Agency Act. It also meets the requirements of the County of El Dorado's Ordinance No. 5096, which requires the preparations of a Countywide Water Plan to support the Urban Water Management Plan development by urban water suppliers.

El Dorado Water Agency (EDWA) plans to update its 2019 WRDMP, which is a policy document focusing on securing long-term water supply and economic prosperity in El Dorado County. The updated WRDMP will continue to be a comprehensive plan that serves a roadmap for countywide water resource management for collective implementation that commiserates the role and responsibility of each implementation agency. As such, it also provides direction to EDWA's future investments to implement the WRDMP to create countywide benefits.

The WRDMP is a "stand alone" policy-level document and is intended to be in a format that easily allows executive-level staff, elected officials, other decision makers, and stakeholders and interested parties to get a clear and concise summary of the plan's purpose, water resources challenges facing El Dorado County, associated resource management strategies, and implementation considerations.

The 2024 WRDMP update will address changed conditions that affect the long-term water supply reliability and economic prosperity in El Dorado County, update the resource management strategies (RMS), update EDWA's implementation policy/guidance, and update specific actions. The recently completed <a href="Upper American River Programmatic Watershed Plan">Upper American River Programmatic Watershed Plan</a> will be incorporated by reference and the applicable RMS will be used to augment the WRDMP's existing RMS for completeness and consistency.

EDWA will follow the same collaborative approach and principles used for the successful development of the 2019 WRDMP. As such, EDWA is reconvening this PAG to assist the plan update process and ensure the integrity and applicability for the resulting product.

Consistent with the guidance provided by EDWA's Board, this PAG is established as topic-specific group under the Countywide Plenary for Water, which was established in 2020 to continue the collaboration among all interested parties in the county. Once the 2024 update is completed, this group will be dissolved. The PAG enables the various interested parties to convene under one setting.

# ATTENDANCE AND MEETING SCHEDULE

It is anticipated that PAG will convene this summer and fall to ensure a timely adoption of the 2024 WRDMP by November 2024. Meetings will be scheduled for up to three hours depending on the topics covered. PAG members are invited to join meetings in-person (remote participation option will be available). Attendance at every meeting is expected. Alternatively, a PAG member can designate an alternate to attend on behalf of their organization. Alternates are expected to be informed of the WRDMP and prepared to provide feedback to inform the WRDMP update. In addition to the attending PAG meetings, PAG members should anticipate some time allocation to review the WRDMP and participate in individual meetings, as needed, to inform update content specific to your agency/organization.

The following is the anticipated schedule for the completion of the WRDMP update:

- May 31, 2024 PAG kick-off call
- Late July/Early August 2024 PAG workshop focusing on Chapters 1 to 3
- September 2024 PAG workshop focusing on Chapters 4 to 5
- October 2024 PAG call for final overview of WRDMP update

November 2024 - EDWA Board adoption of WRDMP

- When disagreeing, be specific about what the problem is and offer positive alternatives.
- Members will use a "parking lot" for ideas that come up but are outside the scope of the meeting.
