### Notes:

- West Slope M&I water demands
  - M&I water demand estimate is based off the 2014 Water Resources Development and Management Plan approach.
  - o Great uncertainty in analysis will be from long-term conservation measures.
  - A range of water demands will be generated to serve the Water Resources Development and Management Plan (WRDMP), the American River Basin Study (ARBS), and Alder Reservoir projects that will need to be in compliance with the 2018 Water Conservation and Drought Planning Legislation. Water target will need to be lower than the 20x2020 Water Conservation.
