## County of El Dorado Assessor's Office Data Request Form

This form allows the public to request the Assessment Roll data from the El Dorado County Assessor's Office. **Note:** *The Assessment Rolls are certified each year in July and reflect a January 1 Lien date. If you are requesting a copy of the Assessment Roll prior to July, you will be receiving the last certified assessment roll reflecting the prior year lien date. A copy of the 2025 Assessment roll is not available until July of 2025 and will reflect data for the 1/1/2025 lien date.*

### Options

- 1. Secured 601 Assessment Roll** - Cost: \$25  
Includes: Roll Year, Assessment Number, Fee Parcel Number, Tax Rate Area, Assessee, Mailing Address, Situs Address, Assessment Description, Assessed Values
- 2. Unsecured 601 Assessment Roll** - Cost: \$25  
Includes: Same as above, but for the unsecured roll
- 3. Master Secured Assessment Roll with Physical Characteristics** - Cost: \$700  
Includes: All 601 Assessment Roll Data plus physical characteristics, exemption amounts and codes, land use codes, and taxability codes. A key is also provided that defines the land use codes, taxability codes, and the exemption codes.

*The Master Unsecured Assessment Roll is included with the Master Secured Assessment roll, if requested in the options on the back of the form.*

### Submission Instructions

1. Print and fill out the back of this form.
2. Choose a delivery method:
